# The What and the Why

#### What is changing?

- On July 1, 2024, the "GMAT Focus Edition" name will revert to the "GMAT Exam."
- The only element of the GMAT Focus Edition that is changing is the name. The exam's structure, content, scoring, and test features will remain the same.
- Scores will still end in a 5.

#### Why is this change happening?

- The "GMAT Focus Edition" name served as a crucial distinction between it and the previous version of the GMAT while both were in the market in late 2023 and early 2024.
- Now with only one version of the exam available, GMAC is transitioning back to using the "GMAT Exam" name from July 1 onward.

#### How will this affect you?

- When receiving and reviewing Official Score Reports from candidates after July 1, 2024, Official Score Reports will say "GMAT Exam (Focus Edition)" instead of "GMAT Focus Edition."
- Additionally, for further clarity, scores from the previous edition of the exam will be labeled "GMAT Exam (10th Edition)" for the version of the exam that was available between 2012-2024.

# Three areas of impact

#### 1. Official Score Reports

- When receiving and reviewing Official Score Reports from candidates after July 1, 2024, Official Score Reports will say "GMAT Exam (Focus Edition)" instead of "GMAT Focus Edition."
- Additionally, for further clarity, scores from the previous edition of the exam will be labeled "GMAT Exam (10th Edition)" for the version of the exam that was available between 2012-2024.

#### 2. Score Reporting Portal

• Depending on how you access files, this change may have additional implications for using GMAC's score reporting data files and the Score Reporting Portal (SRP).

#### 3. GMAT Branding

Due to this change, you may need to update your business and/or marketing materials.



As a result of the name change, there will be minimal changes to the Official Score Reports you receive from candidates:

- "GMAT™ Focus Edition" will be relabeled "GMAT™ Exam (Focus Edition)"
- "GMAT™" will be relabeled "GMAT™ Exam (10<sup>th</sup> Edition)"

# Score Reporting Portal (SRP) Updates For SRP Users

**Scope of Changes:** The string names within the GMAT score reporting API and the score section headings within the CSV-format score data file will be updated to reflect the change in exam names. No changes will be made to the data within the score files.

**Impact:** Depending on how you access GMAT scores, you may need to make an update to your score reporting system to accept the new files on July 1, 2024 to avoid any disruption in receiving GMAT score data:

- You will need to make an update to your system if they are:
  - Retrieving scores via the score reporting API
  - Importing the CSV-format file into a system configured by column headings
- You will not need to make any updates if they are:
  - Downloading TXT-format score data files
  - Importing the CSV-format into a system configured by file index

#### How quickly do I need to update our score reporting system?

If you are retrieving scores via the score reporting API or importing the CSV-format file into a system configured by column headings, you will need to make sure your score reporting system is ready to accept the new files on July 1, 2024, to avoid any disruption in receiving GMAT score data. You will not need to make any updates if you're downloading TXT-format score data files or importing the CSV-format into a system configured by file index. We recommend reviewing the latest <a href="Access GMAT Scores">Access GMAT Scores</a> updates and documents to ensure you and your team are familiar with the score downloading process and can make any necessary changes on July 1, 2024.

#### How quickly do I need to update our website, marketing materials, etc.?

Take your time! It will be made explicitly clear to business school candidates that any reference to the GMAT Focus Edition outside of gmac.com, mba.com, and the registration process will refer to the most recent version of the GMAT Exam. # Additional Resources

#### 1954

The GMAT exam was launched by nine forward-thinking business school deans. It started out with four sections: Verbal, Quantitative, Best Arguments, and Quantitative Reading.



#### 1961

Through further consultation with business schools, a Data Sufficiency section introduced, and 'Organization of Ideas' and 'Directed Memory' were removed.



Reading Comprehension (part of Verbal Reasoning) and Problem Solving (part of Quantitative Reasoning) sections were added to the exam.



#### 1982

Sentence Correction was added as part of Verbal Reasoning.



Critical Reasoning was added as part of Verbal Reasoning.



#### 1994

Analytical Writing Assessment (AWA) was added to the exam, consisting of two essays measuring the candidate's ability to think critically and communicate ideas.



The GMAT exam was delivered in a computer-adaptive testing (CAT) format for the first time.



#### 2012

A new section, Integrated Reasoning, was added to the exam, and AWA was reduced to one essay.



Section Select Order was introduced, giving test takers greater control over their exam experience.



#### 2018

The lengths of the Verbal Reasoning and Quant Reasoning sections of the exam were reduced.



GMAT Online was introduced, offering candidates the option to take the test at home. It was enhanced the following year.



#### 2023

GMAT Focus was launched, with three sections (Data Insights, Verbal Reasoning and Quantitative Reasoning); a more focused exam time of 2 hours 15 minutes; the opportunity for candidates to review and edit answers at the end of their exam; and enhanced score report providing deeper performance insights.
